Our Commitment

As part of its responsibility to its members, the Specialty Equipment Market Association (SEMA) has a long-standing commitment to ensuring that all performance enhancing parts used on the road are emissions compliant. SEMA's comprehensive offering of tools, services, and learning materials provide our members with certainty their parts meet U.S. Environmental Protection Agency (EPA) and California Air Resources Board (CARB) emissions standards.

Our Offerings

SEMA GARAGE	The SEMA Garage is a complete product development resource for manufacturers. The Garage provides access to high-tech tools and services including assistance with all aspects of emissions testing and compliance to demonstrate that vehicles will remain emissions-compliant after a product is installed. Located in Plymouth, Michigan and Diamond Bar, California, SEMA's automotive emissions laboratories enable our members to test their products at an affordable cost. The SEMA Garage performs all tests required to obtain a CARB Executive Order (EO) and/or SEMA-Certified Emissions documentation to certify that a product does not increase emissions compared to an original equipment manufacturer (OEM) part for gasoline and diesel vehicles. Services also include OEM-provided CAD/CAM drawings (Tech Transfer), Measuring Sessions/Installation Center, 3D Printing/Rapid Prototyping, and Emissions Lab & Vehicle Dynamometer testing.
SEMA CERTIFIED-EMISSIONS	SEMA developed the SEMA Certified-Emissions program as an option for members to demonstrate that their products are emissions compliant. Generally, any product that affects airflow into or out of an engine, impacts the containment or delivery of fuel, or affects the functionality of an emissions control system or device must demonstrate emissions compliance to be considered legal for street use. This includes, but is not limited to, intake systems, exhaust components, tuning products, intercoolers, turbos, and superchargers.
BUSINESS ASSISTANCE	The SEMA Garage has helped aftermarket businesses gain CARB approval for over 600 EOs. Over half of the EO applications submitted each year come from the SEMA Garage.
SEMA'S COMMITMENT TO EMISSIONS COMPLIANCE	SEMA has invested over \$20 million to help our member companies and other aftermarket businesses to test and sell emissions compliant products. The SEMA Show, the largest trade show in North America in 2022, features educational sessions on how businesses can comply with emissions laws. SEMA also provides our members with guidance through our monthly magazine and weekly electronic publications.
